Tax free for 2 years, 50% off for the next 4 years from the first year the enterprise has taxable income.

FOR ECO ENTERPRISE



- > To be preferential loaned from a number of funds
- > To be granted green credit in credit institutions, foreign bank branches in Vietnam
- Issuance of green bonds



FOR INNOVATION ENTERPRISES (MINIMUM OF 5% INDUSTRIAL AREA)
